### Personal precautions, protective equipment and emergency procedures

#### **For non-emergency personnel**

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. ## Section 8. Exposure controls/personal protection

### Appropriate engineering controls
