**3. HAZARDS IDENTIFICATION**

<b>Emergency Overview</b>	
<b>Appearance and Odour</b>	: Colourless. Semi-solid at ambient temperature. Slight hydrocarbon.
<b>Health Hazards</b>	: High-pressure injection under the skin may cause serious damage including local necrosis.

<b>Signs and Symptoms</b>	: harmful impurities. : Local necrosis is evidenced by delayed onset of pain and tissue damage a few hours following injection. Oil acne/folliculitis signs and symptoms may include formation of black pustules and spots on the skin of exposed areas. Ingestion may result in nausea, vomiting and/or diarrhoea.

### 4. FIRST-AID MEASURES

<b>General Information</b>	: Not expected to be a health hazard when used under normal conditions.
<b>Inhalation</b>	: No treatment necessary under normal conditions of use. If symptoms persist, obtain medical advice.
<b>Skin Contact</b>	: Remove contaminated clothing. Flush exposed area with water and follow by washing with soap if available. If persistent irritation occurs, obtain medical attention. When using high pressure equipment, injection of product under the skin can occur. If high pressure injuries occur, the casualty should be sent immediately to a hospital. Local anaesthetics or hot soaks should be avoided because they can contribute to swelling, vasospasm and ischaemia. Prompt surgical decompression, debridement and evacuation of foreign material should be performed under general anaesthetics, and wide exploration is essential.
